As per UE Directive 2018/2021, Repower provides electricity from renewable sources through 'Guarantee of Origin' (GO) certificates, committing to purchase and cancel, by March 31 of the following year of supply, an amount of GOs equal to the electricity sold as renewable. The cancellation of guarantee of origin certificates allows for the offsetting of all emissions associated with the electricity consumption covered by GOs. According to the market-based approach, the Scope 2 emissions are considered equal to zero. The coefficient used for calculating the offset emissions is 293,3 gCO₂eq/kWh (source ISPRA).
